ANNEXATION ORDINANCE NO. 487

WHEREAS, on the 19th day of August 2004 AD, a Petition was filed with the Trustees of the **WHEATON SANITARY DISTRICT**; and

WHEREAS, said Petition was executed by the owners of said property being generally known and described as:

Lot 21, Block 5, together with the right of way of Knollwood Drive adjoining said lot, all in Grange Park Addition to Wheaton, being a subdivision of Part of the Northwest Quarter of Section 8, Township 39 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded October 20, 1926 as Document 223492, in DuPage County, Illinois. (P.I.N. 05-08-105-002, commonly known as 0N679 Knollwood Drive, Wheaton, IL 60187)

WHEREAS, said Petition requested the annexation of said territory to and within the territorial limits of the **WHEATON SANITARY DISTRICT**; and

WHEREAS, it was found that said territory above described was and is adjacent and contiguous to the present corporate limits of the said **WHEATON SANITARY DISTRICT**; and

WHEREAS, said territory is within the County of DuPage and said Petition previously filed in said cause is in substantial compliance with the statutes of the State of Illinois, in case made and provided; and

WHEREAS, the Board of Trustees of the **WHEATON SANITARY DISTRICT** believe it is to the best interest of said District that the property hereinafter described be annexed to the **WHEATON SANITARY DISTRICT**.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the **WHEATON SANITARY DISTRICT**, a body politic and corporate of DuPage County, Illinois.

SECTION 1. That the following described property be and the same is hereby annexed to the **WHEATON SANITARY DISTRICT**:

Lot 21, Block 5, together with the right of way of Knollwood Drive adjoining said lot, all in Grange Park Addition to Wheaton, being a subdivision of Part of the Northwest Quarter of Section 8, Township 39 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded October 20, 1926 as Document 223492, in DuPage County, Illinois. (P.I.N. 05-08-105-002, commonly known as 0N679 Knollwood Drive, Wheaton, IL 60187)

SECTION 2. That from and after the passage of this Ordinance, the property hereinbefore described shall assume its proportionate share of the existing bonded indebtedness.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and approval, and the Ordinance and Plat of Annexation shall be recorded with the Recorder of Deeds.
