Billable usage of 0-2 is billed a minimum bill amount; the billable usage is 2.67361 for City of Wheaton customers (conversion from cubic feet to gallons); for all other customers, the minimum billable usage is 2. Flat Rate customers' billable usage is 6.

FOR YOUR INFORMATION

Wheaton Sanitary District (WSD) is an independent municipal corporation which provides sewage treatment for most of the City of Wheaton, and portions of Carol Stream, Glen Ellyn, Winfield, and unincorporated DuPage County. The District has no official affiliation with the City of Wheaton, nor does it currently levy taxes. It finances nearly its entire operation through user charges.

The District is governed by a Board of Trustees who are appointed by the DuPage County Board. WSD's Board meets once a month, on the second Wednesday, at 9:00 A.M., at the District office.

WATER NOT RETURNED TO SANITARY SEWERS

The user charge rate assumes a portion of your year-round water usage is not returned to the sewer system. For other situations (watering and irrigation meters, filling swimming pools, and leaks) where water may not be returned to the sanitary sewer system, please see WSD's website, Key Ordinances, then the most recent ordinance regarding "User Charge, Collection Procedures, and Service Termination."

PAYMENT TERMS

User charges are due and payable within 25 days of the billing date. If the due date falls on a Saturday, Sunday or a recognized National Holiday, payment may be made on the following business day without penalty.

PENALTY CHARGES

A late charge at the rate of five percent (5%) per month, or any part thereof, will be charged on all past due balances. Failure to receive a bill does not exempt you from payment or penalty charges. Your bill is not considered paid until payment is received by the District or its agents.

RETURNED ITEMS

A charge of \$25.00 will be billed to accounts which are paid by check or ACH debit if the check or ACH debit is returned unpaid to the District because of non-sufficient funds, a closed account, or misinformation supplied by the customer or customer's agent(s).

Via Green Pay: Create an account to make a one-time credit/debit card payment, sign up for AutoPay (a monthly withdraw from a checking or savings account), choose billing options, etc.

PAST DUE ACCOUNTS

The District may use both of the following methods to collect on past due accounts:

1. Liens for Unpaid Accounts

The District's general policy is to file liens for past due amounts of \$75.00 or more. A service charge of \$75.00 will be billed to accounts which have liens filed.

2. Water Shut-off or Service Termination

Customers whose account balance is \$75.00 or more, and 60 or more days past due will receive a Notice of Termination. A default fee will apply if the past due balance is not paid by cash in the District's Administrative Office by 4:00 on the Friday prior to the default date. If the full balance remains unpaid as of the default date, then either the water service may be terminated or the sewer may be physically disconnected.

Those whose water service is provided by City of Wheaton, Village of Carol Stream, or Village of Glen Ellyn may have the water shut off. Water service will be reinstated upon payment of the full amount due, including all fees due .

Others may have the sewer physically disconnected. Authorization to reconnect will be given upon payment of the full amount due, including all fees due, and the full cost of disconnection. The owner will be responsible for the costs of reconnection.

FINAL BILLS

If selling your property, you or your attorney must contact the District in writing (form on website) to request an estimated final bill so that the account is paid through the closing date. Requests received less than 3 business days before the closing date will be charged a \$50.00 handling fee.

If you are a renter, please contact the District to inform us of the change (form on website). You will need to handle any prorations, balances, or credits with your landlord, not the District.
